

ORDINANCE No. 2021-07

**AN ORDINANCE OF THE TOWN OF TRIANA RELATING TO ZONING;
AMENDING THE OFFICIAL ZONING MAP, AS LAST AMENDED,
BY CLASSIFYING A CERTAIN PARCEL OF LAND HEREINAFTER
DESCRIBED FROM R-1 TO B-1.**

WHEREAS, application was made for the parcels of land described below to be re-zoned from R-1 classification to B-1 classification at a public meeting held on October 4, 2021

WHEREAS, that application for re-zoning was considered at a public hearing held on October 18, 2021 and approved by the Planning and Zoning Board at that time;

**BE IT ORDAINED BY THE COUNCIL OF THE TOWN OF TRIANA,
ALABAMA AS FOLLOWS:**

SECTION 1: That pursuant to Section 11 of the Zoning Ordinance of the Town of Triana, Alabama, as amended, and the authority granted to municipalities by the Code of Alabama 1975 §§ 11-52-77 and -78, classifying the following areas of real property, which are depicted on the map attached to this Ordinance, from R-1 to B-1.
