ORDINANCE NO 2025-02

AN ORDINANCE OF THE TOWN OF TRIANA, ALABAMA  
FOR THE SETTING OF SALARIES OF MAYOR AND TOWN COUNCIL

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF TRIANA, ALABAMA,  
AS FOLLOWS:

SECTION 1. That the salary for the Mayor of the Town of Triana shall be and is hereby set at the sum of \$1500.00 per month provided that the Mayor shall attend all regular meetings of the particular month or, in the event that the Mayor is unable to attend all regular meetings, that the Mayor is absent due to his/her performance of official Town business.

SECTION 2. That the salary for each Council Member of the Town Council of Triana shall be and is hereby set at the sum of \$750.00 per month provided that the Council Member shall attend all regular meetings of the particular month or, in the event that said Council Member is unable to attend all regular meetings, that said Council Member is absent due to his/her performance of official Town business.


SECTION 3. The Councilperson designated as the Utility Chair shall receive an additional \$250.00 per month combined with the salary designated in Section 2. The Councilperson designated as Mayor Pro Tempore shall receive an additional \$100.00 per month combined with the salary designated in Section 2.

SECTION 4. That this Ordinance shall become effective immediately.


SECTION 5. That all prior Ordinances establishing the pay/salary of the councilmembers and/or Mayor of the Town of Triana are hereby nullified and deemed void.

SECTION 6. If any section, subsection, or phrase of this Ordinance is for any reason held to be unconstitutional or invalid by any Court of competent jurisdiction, such decision shall not affect the remaining portion of this Ordinance.
